If the description does not provide sufficient details to confirm that the quoted item meets or exceeds the specified requirements, that item will not be awarded points in the evaluation matrix.

Factors such as technical compliance, price competitiveness, and delivery timeline will be considered in determining the most responsive and suitable quotation. The order will be placed with the supplier whose quotation best meets the technical requirements and price competitiveness.
