Evaluation Methodology

Only quotations that include **all items** listed in this RFQ will be considered. **Partial quotations will not be evaluated.**

Quotations will be evaluated based on compliance with the specifications outlined in this RFQ. The evaluation will compare the detailed description provided in the RFQ with the item descriptions in the submitted quotations.

Suppliers must ensure that their quotations include clear and complete descriptions of the items offered. If the description does not provide sufficient details to confirm that the quoted item meets or exceeds the specified requirements, that item will not be awarded points in the evaluation matrix.

Factors such as technical compliance, price competitiveness, and delivery timeline will be considered in determining the most responsive and suitable quotation. The order will be placed with the supplier whose quotation best meets the technical requirements and price competitiveness.
